Health care is a **major concern** in the lives of people with disabilities in Pennsylvania. In our plan, we focus on **a critical change** in the system—The Affordable Care Act and its implementation as it impacts individuals with disabilities in Pennsylvania. **Monitoring**, **information dissemination**, and **education about the ACA's impact** are crucial. Additionally, our plan and activities related to health have addressed **training** and **preparing** people with diverse disabilities and from diverse cultures to be **their own advocates** in healthcare.



Our efforts in Education span the focus of **coalition building** and **changing the cultural context within schools** regarding inclusive education to **expanding and developing parent leadership**. In this plan, our parent leadership efforts include a new emphasis on **supporting leadership** in parents of children with disabilities who are home schooled, educated in charter schools, cyber schools, private or parochial schools, etc. **Disability advocacy support** was also provided to diverse parent groups that are organizing and networking around education issues.



Building on our past efforts in supporting self-advocacy, the major emphasis in the current plan is to **develop and support** a statewide self-advocacy organization led by people with developmental disabilities. **Momentum was gained** through the creation of digital and online communication formats that enabled self-advocates to both **teach** and **learn** from one another about **their rights** and **the self-advocacy history and movement**.

In the area of inclusive community, we intend to **increase the capacity** of generic communities and systems to ensure that the systems and supports that are available to the community in general are **accessible** and **equally available**, with appropriate accommodation, to Pennsylvanians with disabilities. For example, one strategy is to increase each community's physical, attitudinal and programmatic accessibility and openness to include **all of its citizens**. Additionally, in the current state plan we focus on strategies which **support** people with disabilities to serve as members and decision-makers of public and private entities in their communities.
